

Recently at the General Assembly, we were honored to welcome Governor Pat McCrory to the House Chamber to give his first of hopefully many State of the State address. ## Death and Taxes



The House Finance Committee voted last week to approve House Bill 101, sponsored by Rep. Susan Martin. This common sense bill would eliminate the death tax in North Carolina. The death tax is the ugliest of all taxes that descends upon a deceased individual's assets (family) upon their death. It is an unfair tax that hurts farmers and family business and punishes growth, success, thrift and hard work. North Carolina and Tennessee are the only states in the Southeast U.S. that have a death tax, and Tennessee is allowing theirs to expire in 2016. This may be our best opportunity to finally separate the words "death and taxes" from each other in a meaningful way.
